## 4. Co-beneficiary's objectives, usual activities and sources of financing:

The main objective of Department of Industrial Engineering of University of Rome "Tor Vergata" is cooperate with national and international entities in order to create CBRN boards with a heterogeneous and high specialized level of knowledge in the frame of safety and security. This is necessary to manage a CBRN event that involves all the aspects of Italian Safety and Security National system.

The Department of Industrial Engineering, by the collaboration collaborating with public and private entities specialized in CBRN events, has developed a Master of Science Course (Protection against CBRN events – hereinafter called CBRN\_MASTER) for First Responders and Decision Makers to give a recognized standard preparation to manage these kind of events. The CBRN\_MASTER is a course of 1 year for Master Degree graduates that gives 60 ECTS-credits. The Department of Industrial Engineering of the University of Rome "Tor Vergata" is characterized by a multidisciplinary composition of expertise, spanning from Mechanical Engineering, to Energy Management and Production and Applied Physics. The research activity is organized in laboratories such as Metallurgy, Mechanical Technology, Machine Design, Technical Physics, Energetics, Applied Mechanics and Physics applied to Nuclear Fusion, Bio and Medical sciences and Cultural Heritage. Our staff is composed at the moment by 51 researchers and 14 technicians.

The teaching activity of the department is mainly focused in courses of Mechanical Engineering and Energetics. The Department PhD program has a course in Industrial Engineering with several sections covering all the area s of the research activity, with approximately 40 students in the three years of the course duration. The Department organizes two Masters in Thermo-Fluidodynamics and Protection from CBRN events and in the near future an additional master in Fusion Technology and Engineering will be activated.

The Department has several connections with public Research Institutions and it is now involved in several European Projects. The major part of the research activity, however, is carried out in collaboration with private companies and institutions, from where the main part of our budget comes from.

5. Co-beneficiary's contribution to the project (detailed description of tasks, responsibilities and input to the project):

The Department of Industrial Engineering (University of Rome "Tor Vergata) has a number of Researchers and Specialists with a highly specialized preparation in Safety and Security matters. The Department of Industrial Engineering has collaborations (for Didactical and Research projects) with the most important public entities involved in the National CBRN Safety and Security System (like Fire Brigades, Italian Army, Navy Seal, Centro Sperimentale di Volo di Pratica di Mare, Croce Rossa Italiana, ARES 118, Istituto Superiore di Sanità, Comitato Parlamentare per l'Innovazione Tecnologica, ENEA, Istituto Nazionale di Geofisica e Vulcanologia) and with the privates entities (like Selex Sistemi Integrati, Otomelara, Tecnhip, WL Gore & Associati, Thales Italia and so on).

The collaborations with these entities have improved the preparation of the Researchers and Specialists that works in the Department of Industrial Engineering, giving them a technicala thorough conscience knowledge of the real needs of first responders and decision makers. For these reasons the Department of Industrial Engineering will be involved in all the Work Packages of the project and in particular will be the leader of the WP5 (Host Nation Support Guidelines) and the WP6 (Training Curricula).

The contribution that the Department of Industrial Engineering as leader will be:

- Work-Package 5: The Department of Industrial Engineering, with the contribution of Researchers and Specialists from the Directive Board of CBRN\_MASTER, will create standards for the validation of define and draft the procedures and a draft set of recommendations for first responders and experts whofrom HSN that have to operate in CBRN contexts, and organize them into the Project's HSN Guideline in order to facilitate them for the technical and legal aspects related to their intervention in a foreign country;s;
- Work-Package 6: The Department of Industrial Engineering, with the contribution of Researchers and Specialists from the Directive Board of CBRN\_MASTER, will lead the work of preparation of e a prototype of training Curricula for personnel of first responseders and law enforcement agencies which are in charge of assistance in the face of CBRN incidents..

The key of this the validation of the CV is the collaboration with responder and experts (like the ones from Italian Fire Brigades Corp) in the aim of CBRN MASTER.
